

# **Dress Try-On and Reservation Agreement**

## **A. Dress Try-On Service**

If you are requesting to try-on a dress or dresses, you will need to complete the Dress Request Form and return it to us by email or fax. We will charge a \$10.00 handling fee per dress along with shipping costs. When available, we ship the dresses to you by FedEx for a 2-day try-on service. We will provide you with a return shipment form. You must return the dress on the second day. Together we will identify a delivery date and a return date. Additional fees of \$50.00 per day will be charged if the dress is returned late. If you decide to reserve a dress after you have tried it on, we will subtract the handling fee from the rental cost. Dresses are for try-on **only** and are not intended for a practice session or a performance. Please keep in mind that many of the dresses will be rented for weekend competitions, showcase performances, recitals, and skating events, so, if you see a dress that you would like to try-on, please contact us as soon as possible.

## **B. Dress Reservation Service and Cancellation Policy**

At the time you make the dress reservation, you will be charged the full-amount of the rental fee as identified on the web site. All rental fees allow for a 1 – 5 day rental. Other arrangements can be made if necessary for a longer term rental. If you have any reason to cancel the dress reservation prior to your request date (date that you want the dress delivered), the following schedule applies:

- If your cancellation is received 21 days prior to your request date, you will be refunded the full rental fee.
- If your cancellation is received within 21 to 7 days prior to your request date you will be refunded 50% of the rental fee.
- Unfortunately, cancellations made less than 7 days prior your request date will not be eligible for a refund.

If you decide to rent a dress from us, we respect the fact that you will want to have a great tan for you competition! Some tanning products however, will produce stains on the dresses that can't be removed. We inspect every dress when it is returned for stone replacement, minor repairs and cleaning. If the dress is returned with tanning stains that are not removable with cleaning, you will be responsible for the cost of the dress. You will be responsible for the cost of the dress for try-on service or rental if it is not returned by the identified date.
